Intern can identify muscles used in specific exercises and name other exercises that use those muscles. Intern can name specific structures damaged by pathologies like diabetes.

Intern can explain why skeletal muscle cells atrophy when immobilized. Intern can describe the impact of respiration on blood pH.

Intern can explain how exercise helps depression. Intern knows where to locate information related to psychological health impacts of various activities.
