COURSE DESCRIPTION

The purpose of HSC 4950 is to acquaint students with behavioral science research methods in a "hands on" fashion, studying a topic of relevance to them and/or their peers: reducing intoxicant-involved sexual consequences (RIISC). The course format will include small group discussions, didactic instruction, journal club meetings, and an individual research presentation. This course will offer a unique opportunity for students to gain hands-on experience to address research question of their choosing. Students will be exposed to all parts of the research process including literature search, data analysis and poster preparation. This course was developed by Dr. Robert Leeman and adapted by Dr. Liana Hone.

PREREQUISITE KNOWLEDGE AND SKILLS

No prerequisites.

REQUIRED AND RECOMMENDED MATERIALS

There is no required textbook. Required readings will be posted in the course canvas page. Student can expect a variety of readings including academic journal articles, magazine and newspaper articles, and selections from popular press books.

COURSE FORMAT

We will meet once per week for in-person discussions. There will be differences in this format week-to-week, including active learning, presentations by expert guest lecturers, lab meetings, data analysis, and research tasks. Typically, we alternate between lab meetings and journal club meetings every other week from 3:00 – 3:50 every Wednesday. Some of our meetings are planned to overlap with CARE and CBHER Research Seminars. In these cases, we will attend the seminar.

Requirements

OVERVIEW

To pass the course, you must complete 9 lab hours per week and complete all assignments, culminating in a poster presentation at the CURE Spring Symposium. As described below, grades will be based on attendance, assignments, and participation.

ATTENDANCE

Based on the structure of the course, it will be difficult to do well in this course without being present regularly. Requirements for class attendance and make-up assignments, and other work in this course are consistent with university policies that can be found at https://catalog.ufl.edu/ugrad/current/regulations/info/attendance.aspx

All students will be held accountable for any information presented in class discussions, lectures, assignments and/or readings, whether they are present or not. If you need to be absent from class, it is your responsibility to first check with your peers about information and/or assignments discussed. If more information is needed about what was missed, please discuss them with the instructor during office hours.

ASSIGNMENTS

Participation

5 points

Lab hours are an important part of a successful experience, thus reliable, active participation in lab hours will be reflected in your grade. Part of the class participation grade will be based on the instructor's general evaluation of your contribution to lab. This includes being present and on time for lab hours, asking for lab tasks, and completing course assignments.

Research Training

5 points

Online human subjects/HIPAA/good clinical practice trainings. You will complete required research trainings and provide documentation of completion.

Literature Search

10 points

Based on training and materials you will receive from a UF reference librarian and the instructors, you will conduct 3 literature searches on specific topics, provide notes regarding your search strategies, a list of 5 relevant references with brief annotation for each. Related to 2 of the 3 literature search assignments, you will be asked to select a questionnaire/variable from among those included in the data collection to focus on for your final project and briefly explain why you have made that selection.

Poster Topic Proposal

10 points

Based on your literature searches, you will select your poster topic and submit a proposal explaining the background and significance of the topic, your research question, and your hypotheses.

Data Analysis Homework

10 points

You will be provided data to conduct statistical analyses for your poster with guidance from the instructors. You will provide your statistical syntax (modified from templates provided by the instructors) and output from the statistical software and a brief description of the results. These assignments will most likely be completed with a combination of class time and time on your own.

Poster Abstract Submission

20 points

Submit abstract for Undergraduate Research Symposium. You will draft an abstract for submission to present a research poster at the UF Undergraduate Research Symposium in early April. The abstract will report on the relevant background literature, methods, results, and an interpretation of results. Your poster abstract must be submitted to the Undergraduate Research Symposium by the deadline.

Poster Draft

10 points

Draft poster, practice then deliver oral presentation at Undergraduate Research Symposium: With your team, using a template provided by the instructors, you will draft your poster for the Undergraduate Research Symposium (URS), which you will then revise based on feedback from the instructors.

Final Poster

30 points

You will incorporate feedback on your poster draft Lastly, you will deliver a brief 2-3 minute overview of the poster and answer at least 1 question regarding the poster at the actual URS.

Extra Credit

2 points

All students will be provided an opportunity to attend a research presentation on campus and provide a brief (1 page) reaction paper on the talk. In addition to the reaction paper, students will be required to provide a selfie/photo of them attending the talk in order to receive full credit. The instructor will mention several research presentations during class announcements. Any presentation mentioned in class can be used for this assignment. The frequency of presentations often declines toward the end of the semester, so it is best to plan ahead!

PARTICIPATION

You are responsible for logging 9 hours per week in line with lab requirements. If you need to miss lab hours, please make up your hours ahead of time. If you are scheduled to run a participant, we ask that you find another research assistant to cover your shift.

STUDENT RECORDING

Per the House Bill 233 Intellectual and Viewpoint Diversity Act, students are allowed to record video or audio of class lectures.
