

Course Grading

The final grade for this course is based on several categories of assignments each weighted differently and listed below.

Discussions

Because this is online course, we can't engage in traditional classroom discussions, so discussion questions are a way to provide a classroom experience online. Each student is required to make **at least** 3 posts for each discussion. An initial discussion post in response to the discussion question must be made by the Thursday in the first week of each module (exact dates will be provided). The remaining to discussion posts should be in response to other students' initial discussion post. Those responses should be substantive and provide additional analysis and/or raise additional questions. Each post should be between 150-200 words.

Case Briefs*

You will have **four** cases to briefs throughout the semester. During the first week of class, I will teach you how to brief a case. The purpose of the case briefs is to help students pull out the key components of a judicial decision and understand how courts interpret the law and arrive at their decisions. The due dates for each case brief are included on the schedule and are also listed below.

Quizzes

In lieu of a final and midterm exam, timed quizzes will be given for each Module based on the assigned readings and lectures. The quizzes will consist of 10 questions and you will have 12 minutes to complete. You will only have one opportunity to take each quiz so make sure that your internet connection is stable and dependable. The lowest quiz grade will be excluded from your final grade calculation.

Final Paper*

As a part of this course you will be required to pick a topic in sport law to write a research paper on. In an effort to reduce the desire to procrastinate (and also to help provide guidance along the way), the final paper is broken up into three parts to be completed throughout the semester. Part II: Case briefs of 3 cases relevant to your topic, due **Sunday, October 14th**

Part III: Article summaries of 3 law review articles, due **Sunday, November 11th**

****Briefs and other writing assignments should be submitted in Turnitin via Canvas, unless otherwise instructed. If a student is deemed to have plagiarized, he or she will be given a zero for the assignment. Please be sure to properly cite all sources directly quoted and paraphrased in each assignment using the APA style. Citation style guides can be found on the libraries website. If you are unsure about how or whether to cite something, please ask the instructor for guidance.***
