# **Course Description:**

This course is designed to further student understanding of foundational legal principles in the field of sport management, especially those principles governing contractual relationships, agency representations, and liability for wrongful conduct. This course builds on the basic principles of law students studied in the introductory Sports Law course.

# **Course Objectives:**

By the end of this course, students will:

• Analyze the pros and cons of various types of business entities

- Assess and evaluate legal risk regarding managerial and ownership issues across business entities
- Interpret and classify types of statutes regarding business entities
- Identify the formation of fiduciary relationships and explain the duties they impose
- Analyze and respond to business law scenarios
- Provide an understanding of the basic principles of legal risk management
- Explore and analyze issues relating to corporate governance
- Assess issues involving mergers and aquisitions

<u>Teaching Philosophy</u>: This class has a mix of cases and case studies. The purpose of such readings is to identify the importance of law in a business context.

**Instructional Methods:** We will have a series of lecture based classes.

This course is an online course, and all class sessions, assignments, and discussions will be delivered through E-Learning (Canvas). The Course is organized in 12 Weekly blocks with the following elements:

#### **Lectures:**

Most weeks will have four lectures. These lectures provide you with crucial information.

#### **Readings:**

Course readings will be assigned for each week, and you will be responsible for material in the readings, even if it is not covered in the lecture. Reading assignments will involve mainly case law. It is important to keep up with the reading so you can learn the key terms and concepts.

# **Exams:**

Three (3) exams will be given during the semester. Exam 1 will cover LLC materials. Exam 2 will cover Corporations & Compliance materials. Exam 3 will cover Business Issues materials. Exam content will be based on material from lectures, PowerPoint slides, and other assigned readings (case law and assignments) from the weeks prior to that exam. NO MAKE-UP EXAMS will be given without an excused, approved absence. Exams are to be scheduled and taken on Cavass. Directions for this process can be found on the Canvas course site.

Any missed exam will result in a zero. If you have a conflict (that warrants a make-up) with the exam dates or times, you must e-mail the course instructor at <a href="mailto:sokold@law.ufl.edu">sokold@law.ufl.edu</a> at least seven days prior to the exam to request a possible make-up time and date.
