Course Description & Objectives

This course examines various areas of law and their application to recreational, collegiate and professional sports. We will emphasize the legal problems and issues faced by professionals in the sport and recreation industry today. Students will utilize critical and analytical thinking to develop a basic understanding of areas of law that affect these industries. Students will:

- Define with legal terms, procedures, and issues affecting the delivery of sport services.
- Describe the judicial system in the United States as it applies to sports.
- Identify and discuss litigation and legislation affecting sport organizations.
- Discuss and develop strategies aimed at reducing the probability of injuries and lawsuits surrounding sport activities.
- Analyze and evaluate the application of the law in various sport context.

Course Policies

This course is primarily done in a combination of a lecture format, case study exercises and team-based learning that examine the application of relevant laws to issues in sports. Video lectures and/or readings will be assigned each week for students to view and read in their own time. We will be using the *HyFlex format for class meetings each week to discuss the readings for that

week and participate in activities that will allow students to apply and synthesize the information from the textbook and cases.

Opinions held by other students should be respected in discussion, and conversations that do not contribute to the discussion should be held at minimum, if at all.

Students will be informed of the due dates for projects and presentations well in advance on the syllabus and Canvas. <u>Therefore, extensions will not be</u> <u>given for assignments and late submissions will only be accepted for up to</u> <u>24 hours after the due date and will receive partial credit.</u> Make-up exams and quizzes will not be offered or given early, unless the student has an excused absence pursuant to the <u>university attendance policies</u> and appropriate documentation is required. It is the student's responsibility schedule time to make up an exam or quiz.

Attendance Policy

Attendance will be taken randomly throughout the semester. If a student has 3 unexcused absences, their final grade will be reduced 10%. If a student has more than 3 unexcused absences, their final grade will be reduced 15%.

*HyFlex Format

This course will be delivered in a HyFlex format and consists of two class sections. The two sections will access the identical course content and activities concurrently on the same meeting days and times. One section will access the class activities remotely and 100% online (e.g. live Zoom class meetings). The other section will have access to the class activities while physically in the classroom.

- Students enrolled in the online section will attend class virtually during the Registrar scheduled meeting days and time as indicated in the syllabus and UF course schedule.
- Students enrolled in the face-to-face section will be expected to attend class in-person during the Registrar scheduled meeting days and time as indicated in the course syllabus.
- Classroom caps for the face-to-face sections have been modified according to CDC guidelines. Consequently, classroom capacities are substantially reduced compared to Spring 2020.

The implementation of this emerging instructional strategy is a growth opportunity for all engaged. Our collective efforts (instructors and students)

will afford the facilitation of high quality educational experiences that fulfill the goals and objectives of the course across all delivery formats. However, as is the case with all innovations, we will inevitably encounter obstacles we must collaboratively overcome together. Thank you for your patience and perseverance.

Course Grading and Requirements

Quizzes and Assessments (15%)

Throughout the semester, several quizzes will be given to help students keep up with the readings.

Assessments are a part of team-based learning and will consist of both individual and group assessments. I will drop your lowest grade among the quizzes and assessments. All assessments and quizzes will be graded objectively.

Case Questions/Activities (9%)

Case questions are helpful for students to understand the assigned cases and talk about them during class. They also act as a valuable study tool for preparing for exams.

Exams (35%)

There will be 3 exams for this course. The exams are not cumulative but will cover all assigned reading up to each exam period. The format for the exams will be covered in class.

Case Briefs (17%)

You will have **four** case brief assignments throughout the semester. During the second week of class, I will teach you how to brief a case. The purpose of the case briefs is to help students pull out the key components of a judicial decision and understand how courts interpret the law and arrive at their decisions. The due dates for each case brief are included on the schedule.



Projects (24%)

Throughout the semester, students will work in groups to research a case and develop an argument in favor *and* against the ruling in the case. Each group will give a presentation of their case to the class. Instructions and the grading rubric regarding this project will be provided in Canvas.

The second major project for this course is an annotated bibliography. Student will work independently to collect and summarize <u>seven</u> law review articles concerning a specific legal topic in sports. Instructions and the grading rubric regarding this project will be provided in Canvas.
