#### **COURSE DESCRIPTION**

Advanced legal aspects expand on the civil legal considerations of sport and entertainment as they relate to venue operators, agents/talent managers, talent, and patrons. Students will gain an understanding of how various bodies of substantive law are applied in the context of the sport and live entertainment industry. A case study-based approach is used throughout the semester utilizing pending and/or finalized matters of law.

#### **COURSE FORMAT**

Our dynamic course structure encompasses a blend of instructional approaches to cater to diverse learning styles. Each class will feature interactive lectures that lay the foundational knowledge, spirited discussions to encourage critical thinking, and insights from industry experts through guest speaker sessions. Engaging case studies will provide real-world context, while simulated exercises will offer hands-on experience. Collaborative group work will further enable the synthesis of ideas and the development of teamwork skills.

#### **COURSE LEARNING OBJECTIVES:**

- Analyze and apply legal terminology applicable to the sport and live entertainment industry;
- Evaluate the United States legal system and international legal systems as they apply to the sport and live entertainment industry;
- Understand which legal constructs and doctrines are implicated in a given sport and live entertainment setting;
- Analyze, work with, and develop documents common to sport and entertainment law settings, including player and entertainer contracts, venue agreements, league constitutions, tour rulebooks, and governing bodies;
- Practice negotiating techniques as they relate to a sport/entertainment contracts;
- Analyze sport and entertainment case law and evaluate the merits of matters based on plaintiff/defendant positions as they relate to changing industry trends;
- Analyze the economic, social, and political impacts of sport and live entertainment industry legal decisions;
- Analyze and apply legislation, standards, and other legal concepts related to sport and live entertainment matters; and,
- Identify a sport/live entertainment negligent act and apply the civil legal process from beginning to end by filing a mock lawsuit, conducting mock discovery, and holding a mock trial.

You will be assigned a role on either the defense or plaintiff side, collaborating with your team to simulate the entire trial process, from filing legal complaints to engaging in courtroom proceedings.

**Docket Manager Tool:** Located at the bottom of each module page on Canvas, the docket manager is a unique tool that simulates the case management systems utilized by legal courts. It will monitor and confirm your completion of each module's requirements, ensuring you are on track with your weekly tasks. #### WEEKLY SCHEDULE

1	See Canvas	This module will provide insight into the totality of the sport and entertainment industry related to legal considerations.	See Canvas for Due Dates
2		This module presents a general overview of the legal process. We will discuss the differences between court districts, from state to federal. We will examine jurisdiction considerations, legal documents, terminology, and the process of a lawsuit, which is mapped beginning to end from a 30,000-foot view.	
3		This module is an introduction to risk management practices that go beyond mitigation and elimination. We focus on legal risk management in the sense that the incident has already occurred.	
4		This module is a deep dive into what negligence is and is not. We examine detailed examples of negligence in the field of sport and entertainment and look at the degrees of negligence where a breach has occurred.	
5		This module covers a very difficult and complex subject, so we will peel back the layers of what defenses to unintentional torts are. We'll discuss the means that entities and organizations have at their disposal to defend themselves from a legal standpoint.	
6		This module will examine defense options for intentional torts like property crimes and crimes by people against others. We will look at examples of assault, defamation of character, trespassing, and the infliction of emotional distress in the workplace.

You and your legal team will review the case presented and progress through the full trial process from filing a complaint to an actual trial.
